*** LEAGUE NOTES ***

- Matches will be played at the Apple Valley Community Center, 14603 Hayes Rd. *Please car-pool as often as possible to alleviate congestion in the parking lot.* **NOTE – NO MATCHES ON FEBRUARY 14TH – VALENTINE'S DAY!!!**
- Adult Leagues are created for adult attendance only. If you MUST bring children to the game, a non-playing adult (1 adult per 2 children) must supervise them at all times. Players not adhering to this policy will not be permitted to participate in the matches.
- Matches shall consist of 3 games to 25 points, winning by 2 points with a 27 point cap, using RALLY SCORING. In RALLY SCORING, if a team fails to serve properly, return the ball, or commits any other fault, their opponent wins the rally and scores a point, even if that team did not serve that point. The results of winning a rally are: If the serving team wins the rally, they score a point and continue to serve. If the receiving team wins the rally, they will score a point plus gain the serve.**
- In the event of inclement weather team managers should call the AVPR weather hotline after 4:00 p.m. at **952-953-2399, Option 1-Weatherline, then Option 1: Adult Athletics**. If matches are cancelled, they will be re-scheduled at the end of the regular season, prior to play-offs.
- Your matches will be officiated by **METRO VOLLEYBALL OFFICIALS**. The Official will turn in your match scores.
- Please read the schedule carefully. The season will consist of 9 league matches. You will play each of the other 9 teams once followed by **Play-offs on March 13, 20, (27, if needed) – SEE BACK SIDE OF SCHEDULE**. Gift Certificates will be awarded to the League Champs and Runners-Up, and the 2 Play-Off Champs. League Champs will also receive a t-shirt for each of their players.
- NOTE:** All teams will be sanctioned with MRPA as "B or C" Teams. The Winner & Runner-Up of the Women's Power League will become the representative from Apple Valley in the MRPA STATE WOMEN'S VB TOURNAMENT (fee paid by AV Parks & Rec. Dept.) on March 10-11 at the A.V.C.C.. (More info to be given to the winning teams, closer to the date...) The 3rd Place Team will be the alternate team if 1 or 2 can't make it., if they cannot attend, we will continue down the standings in order to have 2 teams represent our League in this Tournament
