



## PAVO UNIFORM CODE AND LIST OF APPROVED VENDORS

The following uniform is required of all PAVO officials receiving fees for their services:

**Shirt:** The PAVO volleyball uniform shirt is an all-white polo-style shirt with the official embroidered designation ("Volleyball Certified Official") on the left sleeve, an optional Velcro patch on the right side of the chest, and an optional pocket on the left side of the chest.

**Slacks:** Navy blue.

**Shorts:** Navy blue; allowable only for tournament play when high temperatures exist.

**Shoes:** All white leather.

**Socks:** White crew.

**Belt:** Black or dark navy blue leather.

**Vest (optional):** White, sleeveless sweater vest worn over a uniform shirt; may be worn during the match by either referee.

**Sweater (optional):** White V-neck pullover with embroidered designation on left chest; may be worn during the match by either referee.

**Jacket:** Navy blue or white windbreaker type recommended if a jacket is worn to the court area; should not be worn during the match.

**Other:** Lanyard, whistle, penalty cards (concealed from view), timing device with second hand. A ball gauge, net measuring device and rule book are recommended.

*NOTE: Complete specifications regarding uniform shirt, vest and sweater criteria are available from the PAVO Central Office (888/791-2074). The only fabrics (weight and type) and styles allowed are those approved by the PAVO Board of Directors.*
